Vision is to create an alternative to a disposable society by making repair education accessible to all, to build a stronger, waste-free community and support vulnerable people within our city. They do this by taking in unwanted second-hand goods and refurbishing and repairing them, giving them a new lease of life and selling these on at affordable prices or gifting them to people who need them most. They also run regular workshops in various repair techniques and skills around sewing and textiles, and furniture and woodwork, to empower people and give them the opportunity to learn to mend their own belongings, saving them money, giving them a brand new skillset, and helping the environment.
